1. Adoption of the draft agenda & minutes

The draft agenda and minutes from 5th December 2023 BDSG meeting were adopted as final. The BDSG meeting minutes are regularly published on the EMA website (<u>here</u>).

Peter Arlett (EMA) introduced and welcomed the new HMA BDSG co-chair Jeppe Larsen, who is a Head of the Medical Devices department at the Danish Medicines Agency. Jeppe was appointed by the HMA Management Group in January 2024 to replace Jesper Kjaer, who left the Danish Medicines Agency in December 2023.

The BDSG members also welcomed Anne Cambon-Thomsen (CNRS, FR), who is an Ethics representative to the Big Data Steering Group.

Action EMA: to organise a dedicated call between the BDSG co-chairs and Anne Cambon-Thomsen, to discuss how to enrich the BDSG work programme from the ethics perspective.

2. Demo series of AI tools: AI@MPA toolbox

Gabriel Westman (MPA) gave a brief introduction to the AI@MPA toolbox, a secure, GDPR-compliant cloud-based platform to access AI-powered regulatory support systems developed by MPA. Four tools were presented to BDSG members (three tools in production and one in deployment):

- PICROSS natural language processing (NLP) to identify semantically similar sentences in the complete corpus of European medical product information documents.
- M-RECON Semantic document-level matching to identify relevant guidelines and approved products of relevance for a specific procedure.
- PACKSIM Computer vision for detecting drug package similarity.
- PhaVAI NLP for predicting serious events from reported terms and free text to improve efficiency in pharmacovigilance by triaging incoming adverse event reports by seriousness.

The AI@MPA toolbox was deployed on 10 November 2023, with seven NCAs having access to this hub so far. An invitation to request access to the toolbox was issued to the other EU Agencies during the meeting and BDSG members' organisations willing to access the system should contact Gabriel Westman directly for further details.

The 'AI in pharmacovigilance (PhaVAI)' tool is not yet accessible outside the Swedish Medicines Agency. NCAs have already been invited to join (by expression of interest directly to Gabriel Westman) the training on the multi-lingual ADR triage model through federated machine learning at the MPA onpremise infrastructure. The group congratulated Gabriel Westman and MPA colleagues with the launch of the AI@MPA toolbox and noted that a survey on user experience and regulatory usefulness of the toolbox will be launched by MPA in the second half of 2024.

BDSG members noted the launch and roll out of several national initiatives on AI and the need to reflect this under experimentation topic of the AI workplan to 2028 to map the Network AI activities

and signpost to the different AI tools available for the EU Regulatory Network (Action Luis Pinheiro (EMA).

3. Multi-annual AI workplan – planning the work on AI

The Multi-annual AI workplan to 2028, prepared under the joint HMA-EMA Big Data Steering Group, was adopted by EMA MB and HMA in December 2023. As the implementation and maintenance of this workplan will be overseen by BDSG, the detailed planning exercise is required to identify the key milestones and deliverables, define roles and responsibilities, and appoint the BDSG sponsors.

The group discussed the activities foreseen under the 'Guidance, policy and product support' and 'Tools and technologies' workstreams, with the discussions sponsored by Gabriel Westman and Luis Pinheiro.

The detailed summary of the meeting discussions for two workstreams is captured in the attached document.
