1. Adoption of the draft agenda & minutes

The draft agenda and minutes from 16th June BDSG meeting were adopted without change.

2. The new BDSG composition and BDSG workplan

The co-chairs welcomed the new and reappointed BDSG members and gave the floor to each member for a short introduction. The current group membership can be found in the slides attached. The group also noted that the updated Big Data Workplan 2022-2025 was published in July and will guide the work of the Big Data Steering Group in the coming years.



Action: EMA to ensure that the updated BDSG Workplan is also published on the HMA website.

3. Patient Experience Data reflection paper - drafting and next steps

Juan Garcia (EMA) gave an update on the Patient Experience Data (PED) initiative and its relevance for the Big Data Steering Group work. The work progresses in line with the actions established following the 2022 multi stakeholders' workshop and with the key priorities identified, namely the development of the PED reflection paper and exploring how to improve the PED data transparency.

Rosa Gonzalez-Quevedo (EMA) then presented the main deliverables of the prioritised actions and focused on the areas of synergies and collaboration with BDSG. It was highlighted that the updated BDSG workplan already includes some of the PED actions, e.g. review on the utility of eHealth/social data, input into the reflection paper, engagement to populate HMA EMA data catalogues, dialogue with patients' organisations on training needs.

The group was also informed that the reflection paper (RP) is anticipated to be released for public consultation by the end of Q1 2024 and will aim set out the high-level principles on the EU approach to generate, collect and analyse PED in the EU. The first proposal for elements to be included in reflection paper was discussed with the BDSG members. The document will be drafted with experts from the Network which will decide on elements to be included in this RP. A call for BDSG volunteers to join the external drafting group (for PED RP) will be issued after the meeting to BDSG members. The volunteers will also be added to the PED expert community, a group that will provide expertise on subsequent deliverables on PED.

Action: EMA to send a call for volunteers to BDSG to join the PED expert community and the RP drafting group via a dedicated email.

George Paliouras (Demokritos, GR) welcomed the initiative and acknowledged the multiple challenges that need to be addressed and considered in the RP: systematic data collection, data quality aspects, diversity of data, selection of data sources etc.

The following additional comments were voiced by the group for consideration for the RP drafting:

- Potential data governance issues: conflicts of interest, transparency, data ownership, etc.
- Consider aspects of registration/cataloguing PED studies in the HMA EMA catalogues of data sources
- Guidance for assessors when to use PED in drug evaluation.
- The key deliverables of the future RP that will be relevant to BDSG should be reflected in the BDSG workplan.
- Launching a programme of proof-of-concept studies to establish PED value.

4. Artificial Intelligence - Orientations and next steps

Gabriel Westman (MPA, SE) gave a quick update on the status of the reflection paper (RP) on the use of AI in the medicinal product lifecycle, which was released for public consultation in July 2023. The <u>document</u> is open for comments until the end of this year.

Luis Pinheiro (EMA) informed the group on the key AI related activities undertaken at EMA, including the development of an AI roadmap to 2027, which is being developed in collaboration with the network. The detailed discussion/consultation with the BDSG members is scheduled at the October BDSG meeting. A request to provide an overview of the major ongoing AI activities in their respective organisations will be sent to BDSG members in early October.

Action: EMA to consider presenting a demo on the ChatGPT pilot and lessons learned on its use to understand technology and limitations for different use cases.
