Subject: Withdrawal of Tuznue (EMA/H/C/005066), trastuzumab, 150 mg, powder for concentrate for solution for infusion

Dear Dr. Harald Enzmann,

We would like to inform you that, at this point of time, Prestige Biopharma Belgium BVBA has taken the decision to withdraw the application for Marketing Authorisation of Tuznue, trastuzumab, 150 mg, powder for concentrate for solution for infusion, which was intended to be used for the treatment of adult patients with HER2-positive metastatic and early breast cancer, and metastatic gastric cancer.

This withdrawal is based on the view that CHMP considers that at this time, the data provided would not be sufficient to support a positive opinion on the marketing authorisation of Tuznue (trastuzumab).

There are no ongoing trials or compassionate use programs for Tuznue.

We reserve the right to make further submissions at a future date in this or other therapeutic indication(s).
