COMMITTEE ON HERBAL MEDICINAL PRODUCTS (HMPC)

Meeting report, 11-12 November 2009

The HMPC held its 32nd meeting at the EMEA on 11-12 November 2009.

Upon recommendation from the MLWP, the HMPC adopted the following <u>final Community herbal</u> monographs and related documents:

- 'Community herbal monograph on *Curcuma longa* L., rhizoma' (EMEA/HMPC/456845/2008)'
- 'Community herbal monograph on Gentiana lutea L., radix' (EMEA/HMPC/578324/2008)'
- 'Community herbal monograph on *Hamamelis virginiana* L., cortex' (EMEA/HMPC/114583/2008)
- 'Community herbal monograph on *Hamamelis virginiana* L., folium' (EMEA/HMPC/114586/2008)
- 'Community herbal monograph on *Hamamelis virginiana* L., folium et cortex aut ramunculus destillatum' (EMEA/HMPC/114584/2008)
- 'Community herbal monograph on *Hypericum perforatum* L., herba' (EMEA/HMPC/101304/2008) (well-established medicinal use)
- 'Community herbal monograph on *Hypericum perforatum* L., herba' (EMEA/HMPC/745582/2009) (traditional use)
- 'Community herbal monograph on *Juniperus communis* L., pseudo-fructus' (EMEA/HMPC/441929/2008)
- 'Community herbal monograph on *Salvia officinalis* L., folium' (EMEA/HMPC/331653/2008)
- 'Community herbal monograph on *Taraxacum officinale* Weber ex Wigg, folium' (EMEA/HMPC/579636/2008)
- 'Community herbal monograph on *Taraxacum officinale* Weber ex Wigg., radix cum herba' (EMEA/HMPC/212895/2008)

Upon recommendation from the MLWP, the HMPC adopted the following <u>draft Community herbal</u> <u>monograph</u> and <u>draft Community list entry</u>, to be released for public consultation until 15 April 2010:

- Draft 'Community herbal monograph on *Vitis vinifera* L., folium' (EMEA/HMPC/16635/2009)
- Draft 'Community list entry on *Hamamelis virginiana* L., folium et cortex aut ramunculus destillatum' (EMEA/HMPC/704562/2009)

After assessment of *Salvia officinalis L.*, folium, the HMPC considered that it cannot establish a monograph on sage leaf essential oil due to safety concerns (high levels of thujone). The HMPC therefore adopted a draft public statement (EMEA/HMPC/726698/2009), which will be published together with the draft assessment report and the list of references for public consultation until 15 April 2010.

The assessment of *Echinacea angustifolia* DC., radix did not result in the establishment of a draft Community herbal monograph because of insufficient data as regards the period of traditional use. The HMPC adopted a draft public statement (EMEA/HMPC/726698/2009), which will be released together with the draft assessment report and the list of references for public consultation until 15 April 2010.

The assessment of *Euphrasia officinalis* L., *Euphrasia rostkoviana* Hayne, herba concludes on the lack of adequate data on the safe use and plausibility of pharmacological effects for certain preparations for ocular and nasal use. The HMPC adopted a draft public statement (EMEA/HMPC/727465/2009), which will be released together with the draft assessment report and the list of references for public consultation until 15 April 2010.

The committee looks forward to receiving additional data, if available, to allow the publication of monographs on Echinaceae angustifoliae radix and Euphrasiae herba.

Appointment of Rapporteurs

The HMPC appointed Rapporteurs for the preparation of Community herbal monographs/Community list entries on Leonuri cardiacae herba, Citri bergamiae aetheroleum and Terebinthina laricina.

Report from the Working Party on Community Monographs and Community List (MLWP)

The MLWP held its 23rd meeting at the EMEA on 9-11 November 2009. In addition to the work that supported the adoption of the above-mentioned documents by the HMPC, the MLWP made significant progress on the scientific work relating to draft list entries on Thymi aetheroleum and Vitis viniferae folium and a draft monograph on Quercus cortex.

The MLWP also discussed draft monographs on Arctii radix, Cinnamomi cortex, Cinnamomi aetheroleum, Hederae helicis folium, Millefolii herba, Oleae folium, Symphyti radix, Tanaceti parthenii herba and Violae tricoloris herba cum flore as well as the preparation of monographs on Matricariae aetheroleum, Matricariae flos and Visci albi herba.

Quality Drafting Group (Q DG)

A meeting of the Q DG was held on 14 October 2009.

The HMPC adopted the 'Guideline on selection of test materials for genotoxicity testing for traditional herbal medicinal products' (EMEA/HMPC/67644/2009). The guideline together with the overview of comments received during public consultation will be published.

The HMPC adopted the revised 'Guideline on declaration of herbal substances and herbal preparations in herbal medicinal products/traditional herbal medicinal products (EMEA/HMPC/CHMP/CVMP/287539/2005 Rev.1). After adoption by CHMP and CVMP, the guideline together with the overview of comments received during public consultation will be published.
