1. Adoption of the draft agenda & minutes

The draft agenda and minutes from 22nd March 2024 BDSG meeting were adopted as final. The BDSG meeting minutes are regularly published on the EMA website (<u>here</u>).

2. Planning of the annual BDSG workplan review

Peter Arlett (EMA) informed the group about the upcoming BDSG workplan review. It is foreseen that the new iteration will be aligned with the Multi-annual AI workplan 2023-2028 and the ongoing revision of the EU Network Strategy to 2028. The revised BDSG workplan will incorporate any new activities or deliverables on topics that BDSG has an oversight of and will feature updates of the existing activities. A dedicated strategic discussion will be organised at a future BDSG meeting, to brainstorm and identify gaps or new areas where BDSG should consider actions for its workplan (longer term perspective).

In addition, the group noted the ongoing discussions at a senior EU leadership level regarding a wider data governance review (including BDSG and the Network Data Board), which could influence the planning and revision of the BDSG workplan (possibility of a combined workplan with the Network Data Board).

3. How to best capture national (NCA) activities with RWD/E for the drafting of the 2nd report on experience with regulatory-led RWD studies

Stefanie Prilla (EMA) reminded the group of the steps undertaken to capture the national (NCA) studyrelated activities with RWD/E. She raised a follow up discussion with BDSG (due to limited feedback received so far) on how best to collect information from NCAs for the 2nd report on experience with regulatory-led RWD studies and feature some of that information in the upcoming RWE News Flash.

BDSG agreed that collation of a comprehensive catalogue of all NCA studies will not be feasible. Instead, it was agreed to pursue a higher-level summary (qualitative) information on national study activities. To obtain relevant information it was suggested reaching out to colleagues outside the RWE ESEC Special Interest Area (e.g. HMA) and collect feedback via a short survey.

Noting that the, Swedish Medicines Agency (MPA) was the only NCA so far to have provided a detailed reply to the survey, the BDSG supported contacting MPA for an interview to feature relevant national activities in the next RWE News Flash. Other Member States could feature in future news flashes over time.

Action: Stefanie Prilla (EMA) to consider engaging the BDSG members in helping to draft a questionnaire for collection of information on national study activities and conduct direct interviews with the National Competent Authorities.

4. Progress on RWE reflection paper

Olaf Klungel (UU, NL) presented a status update of the draft Reflection Paper on Use of real-world data in non-interventional studies to generate real-world evidence. The reflection paper discusses methodological aspects of Non-interventional studies (NIS) to be addressed by relevant stakeholders involved in planning, conduct and analysis of NIS using RWD to generate RWE for regulatory purposes. The current draft document will be released for public consultation at the beginning of May, following the CHMP adoption in April 2024.

Olaf Klungel (UU, NL) briefly introduced the process for the development of this paper and presented an overview of each section (i.e. Scope, Legal and regulatory requirements, Study design, Governance and Transparency, Data quality, Statistical analyses).

Some clarifications were sought by the BDSG members regarding the paper scope, inclusion of ethical considerations for the data source and data quality aspects, also whether the draft guidance is aligned with the relevant existing EU national guidance.

The group welcomed the update and congratulated the drafting team on the major milestone achieved. It was also noted that the reflection paper will be introduced and presented at the joint HMA-EMA Big Data Steering Group workshop on RWE methods on 14 June 2024.

Action: The drafting team (coordinated by Juan Jose Abellan Andres (EMA)) to consider validating the reflection paper with the relevant national guidance (on use of RWD in non-interventional studies to generate RWE) during the public consultation period.

Action: Patrice Verpillat (EMA) to send out the invitation to register for the RWE methods public workshop to BDSG.

5. Upcoming on LLM webinar and the guiding principles draft structure

Luis Pinheiro (EMA) gave a short introduction to the AI Masterclass webinar on the use of Large Language Models which is scheduled to take place on 26 April 2024. The webinar is part of the HMA-EMA Big Data Steering Group (BDSG) Multi-annual AI workplan 2023-2028 deliverable and is aimed at the EU Regulatory network colleagues only. The webinar is structured in three sessions and will offer an opportunity to discuss and further refine the draft Guiding principles on the use of large language models in regulatory science and for medicines regulatory activities. The final draft of the guiding principles will be distributed to BDSG for consultation and a subsequent endorsement, with the publication expected in June 2024.
