Important additional information on use of the timetable:

Interim dates/milestones such as BWP Comments, UER, TC and BWP **are not made** available to applicant during the procedure; however, they are reflected in the final ER as adopted during the relevant CHMP meeting/date. The adopted CHMP ER will be sent to the Applicant/PMF Holder.

Abbreviation/Notes

PER (Preliminary Evaluation Report). This is circulated to the Applicants.

This report sets out only the preliminary conclusions of the Coordinator. This report in no way binds the BWP/CHMP and is sent at this point for information only.

TC (Teleconference) – TC dates will be confirmed in writing to experts.

TC takes place with Coordinators and the European Medicines Agency staff to discuss the evaluation and critically analyse the different objections/concerns raised in the Coordinators' ER and BWP comments.

- UER (Updated Evaluation Report)
- BWP (Biologics Working Party) Takes place the week previous to CHMP

CHMP (Committee for Proprietary Medicinal Products)

Guidance on PER and responses:

* Whenever the PER (i.e. draft ER) recommends a **List of Questions**, the PreER should be considered for information only and **the PMF-H should wait until its CHMP adoption**, **i.e. no interim responses can be submitted** prior to the CHMP Adoption (unless if ER's recommendation changes during the PMF comment phase or Teleconference from List of Question to interim clarifications on UER).

** Whenever the draft ER raises issues that only need clarification and not assessment (**interim clarifications** selected), the PMF-H clarification can be provided at the latest by the BWP comments deadline, with the aim to expedite the PMF certification without a List of Questions. If clarification is is not timely submitted, not resolved or additional comments are raised during the PMF comment phase or Teleconference, the full List of Questions will remain to be resolved.

A standard clock-stop of **1 month will apply** and responses should be submitted in accordance with the timetables published on the EMA website (https://www.ema.europa.eu/en/human-regulatory/research-development/non-pharmaceutical-products/plasma-master-file/plasma-master-file-pmf-submissions). For 30d clock stop responses submission date, please refer to column "Start/ or response 30d clock stop" stating the latest date for 30d clock submission.

If the PMF-H considers the need for a longer or immediate response timetable, the date proposal together with the response TT reference proposal should send with a justification to the PMF EMA contacts as soon as possible, after the receipt of the Update ER.

Immediate responses (i.e. Monday/Tuesday after CHMP) can only be submitted whenever the coordinator has previously ticked 30d assessment and only when coordinator considered that the questions raised require minor assessment and a short 30d TT assessment.
