Union Controls in CTIS

CTIS allows European Commission users to **conduct Union Controls** in order to verify that the EU/EEA Member States correctly supervise compliance with the Clinical Trial Regulation (EU) No 536/2014 (CT Regulation), and to verify that the regulatory system applicable to clinical trials conducted outside the Union ensures that point 8 of the Introduction and general principles contained in Annex I to Directive 2001/83/EC is complied with; or that the regulatory system applicable to clinical trials conducted outside the Union ensures that point 8 of the State S

Create and share Plans / Programmes

1. On the CTIS 'Union Control' tab, the **Plans and Programmes** are listed in the first section. Users can click on the **'+ New**' button to fill in a new Plan / Programme form.
